QUEST

John Key is the man in charge and he offers some basic guidelines:

Initially you should consider whether you meet the requirements of Bronze which is about the basic running of your L.R.A: rules; communication; finance; minutes. You need to have your accounts independently verified by an auditor usually prior to your AGM.

The key to a successful application is providing the necessary evidence in electronic form. It is not sufficient to say you do something - you must evidence it, e.g. for Bronze 1 you might supply your rules, a screenshot of an email that shows you have sent your rules to members, AGM minutes showing election of officers.

Application and Information pack is available from Head Office.

"GIZ A JOB"

Volunteers are required from amongst the membership to perform the following important tasks:

- 1. Scrutinise Board expenses annually
- 2. Stock taking of supplies

Do you have time to spare? Do you have the necessary experience?

Applications to reach Head Office (electronically will suffice) by 30 September 2015.

HOW DO YOU DO IT?

Phil Reade (Wolverhampton L.R.A.) built up membership and is now the fastest growing L.R.A. in the country. Here's how:

- 1. Request a copy from local County F.A. of all registered Referees for season 2015-2016
- 2. Look up ALL named referees in your city, town, and area.
- 3. Telephone each one that is NOT listed on your database; all R.A's should have one.
- 4. Explain to them what an R.A.is and how it can benefit each member, the cost, what the insurance plan covers etc.
- 5. Ask all local Referee Secretaries of the Leagues to attach an R.A. flyer to their next email to the Referees requesting that they become members of the local R.A.
- **6.** Attend all seminars that County FA's are hosting for newly qualified referees who have just passed the course and present yourself to them with a background of who you are etc.

This worked for Wolverhampton. Yes it's time consuming but if you care for your members and you want it badly enough then the Secretary/Chairman/Treasurer of each R.A. must "**GO FOR IT.**"

(David Crick Reports)

- Cooling off period at Steps 3 & 4 Northern Premier League has signed up for a 1-year trial -more may yet do so
- Access for The R.A. to referee training courses to promote the Association if this is being denied, then I need to be told immediately
- Waiver wording for County F.A.'s to be added to any application to become a Referee "I have no objection to The Referees' Association being given my contact details" delete if not applicable

The FA has decided to combine Group Legal and the Professional Game departments with Football Governance and Regulation, to be led by Darren Bailey. These changes will see Jonathan Hall, Roger Maslin and Alistair Maclean leaving The FA Group.
